Question 1: What water quality issues do you see in the watershed?

- Ditches getting bigger south of Arby's yale
- Accumulation of trash/garbage
- Conveyance (whole/land)
- Getting community/individuals involved
- Storm sewer efficience capacity/clogged?
- (People & Wendy) House on corner of Wellworth & Delmar filling lot causing problems
- Corner lots is for sale
- Need to monitor what happens in the neighborhood.
- Berms built around house to keep out water pushes the water onto others.
- (Pat) Remove house and build a retention pond on the lot.
- Need drainage ditches along Wellworth/Wentworth
- Filling of lot is causing siltation problem.
- Storm sewer from Warren north of Charles discharges into area south of Charles.
- Storm sewers are clogged after storm
- Have check wells whenever it floods disinfect wells (8-10 people with well problems)
- Sewer backups (7-8 into basements, 6 insurance claims)
- Flooding in basement & ponding in yard (2114 F.V. build berm)
- 4813 Delmar culvert built with plywood under road first duplex closer to F.V.
- 2122 Wentworth water comes down Lamar from duplex into ditch (2115 Lamar)
- Someone before duplex built came in and filled the open lot open waterway unincorporated area
- City dumps storm sewage John Ekberg has map of where the water goals Don has it
- Need to test wells look into free tests
- What would it cost for city water to serve area?
- Blocked sewer
- Possibly broken sewer
 - getting springs shooting up in the middle of yards
 - reports of gurgling sounds underground
 - foundations: chimney facing undercutting
- Surface runoff
 - old hilander under construction now
 - Ohio parkway acting as a dam (25th St. same)

Question 2: Who is responsible for improving the water quality of Welworth/Wentworth Creek?

• Winnebago County put smaller pipes in "V" style open ditches when Charles was reconstructed.

- Silt fabric clogged drainage inlet rims of sewer inlets higher than ground.
